DECLARATIONS

1. I hereby declare that I am the owner/owner’s agent of the animal(s) described overleaf and that to the best of my knowledge the particulars shown on this form are true and complete.
2. I hereby confirm that I, the owner, have examined the stock and seen no sign of FMD or other notifiable disease.
3. **I HEREBY CONFIRM THAT THE STOCK COMES FROM A PREMISES WHICH HAS HAD NO MOVEMENT OF FMD SUSCEPTIBLE ANIMALS ONTO IT IN THE PREVIOUS 6 DAYS (OTHER THAN PERMITTED EXCEPTIONS).**
4. All of the animals have originated from establishments that have received regular animal health visits from a veterinarian for the purpose of the detection and signs of disease.
5. No analysis of samples taken from animals on the holding or other samples has shown that the animals in this consignment may have been exposed to any disease or condition that may affect the safety of meat or to substances likely to result in residues in meat.
6. I hereby confirm that the movement complies with the relevant general licence.
7. I further declare the animals are correctly marked and are tagged with official UK tags and any documentation corresponds to the relevant ear tags.
8. I understand that any false declaration made on this form could result in prosecution under the Animal Health Act 1981.
9. I hereby confirm that any medication ceased at the relevant mandatory time before the sale for slaughter in accordance with the Veterinary Medicines Act 2005. The withdrawal period for any treatment administered to this animal(s) has been observed / declared.
10. I/We certify we have valid Passports for all Cattle born after 1st July 1996, and these have been properly signed and completed.
11. All cattle born after 1st January 1998 are warranted to have double tags affixed and that each of the tags matches the Ear Number stated on the Passport.
