Registration

Due to the changes made to the Money Laundering Regulations, we are now required by law to verify the identity and address of everyone who offers, bids or buys at our Bagshaws Property Auction.

Therefore, you will need to register before the auction starts if you are intending to bid!

We will need one proof of photo ID and one proof of residence. Failure to produce the correct ID will mean you will not be eligible to bid at the property auction.

How to Register

- In person at any of our offices, with your original paperwork, where we will verify the ID
- A professional body (Solicitor, accountant etc.) can also certify your ID and directly send it on your behalf to bakewell@bagshaws.com at least 7 days prior to the auction (these parties may charge for this service). For this to be accepted, the professional body must also provide written confirmation that the ID documents can be relied upon for AML regulatory purposes.
- Bring all the relevant documentation to the auction venue one hour before the commencement of the auction to register, free of charge.

If you are bidding on behalf of a company, ID is required for all beneficial owners with 25% or more share or otherwise having significant control, you will also need to show a copy of the Certificate of Incorporation, a list of directors, Memorandum and Articles of Association, Register of shareholders or members and a letter of authority on Company letterhead, signed by a beneficial owner, prior to signing the contract.

Please be advised if you are the successful bidder

Proof of funds will be required; please ensure they are available on the day of the auction.

Deposit payments should be made via your solicitor on the day of the auction. Should this not be possible only payments by BACS/bankers draft will be accepted by Bagshaws LLP.


What we need you to bring with you on Auction day

Under the Money Laundering, Terrorist Financing and Transfer of Funds (Information on the Payer) Regulations 2017 ("the ML Regulations") there are a few documents that we require from the buyer, the successful bidder, and/or the party providing the funds. We or a solicitor will need to **verify** these documents before the individual can be allowed to bid at auction or an offer can be accepted.

Proof of ID Documents accepted

- Current Passport
- Current Driving License
- Firearms License

Proof of Address Documents accepted



- Current tax bill from your local authority
- Latest mortgage statement
- Latest bank statement
- Latest utility bill (not mobile phone)

All address documents need to be dated within 3 months

If you're the successful bidder and/or buyer, we will need to see your

Proof of Funds Documents accepted



- Agreement in Principle/Mortgage in principle
- Bank Statements of your deposit (For Mortgage Buyers)
- Bank Statements showing Cash amounts (For Cash Buyers)
- Memorandum of sale (if selling property to fund)
- For gifted funds, a letter from whoever gifted the money
- Evidence of Money left in a will
- Receipts from shares sold
